






DITCH TYPE STREET TYPICAL SECTION RESIDENTIAL STREET WITH UTILITIES




PARKING SPACE PAVEMENT MARKINGS




1/8" RADIUS



GENERAL NOTES:

- 1. A GROOVE JOINT 1" DEEP WITH 1/8" RADII SHALL BE REQUIRED **EXPANSION JOINT WILL BE REQUIRED AT 45' INTERVALS NOT TO** IN THE CONCRETE SIDEWALK AT 5' INTERVALS. ONE 1/2" ADJACENT CURB. A SEALED 1/2" EXPANSION JOINT WILL BE EXCEED 50' AND MATCHING EXPANSION/CONSTRUCTION JOINT IN REQUIRED WHERE THE SIDEWALK JOINS ANY RIGID STRUCTURE.
- SIDEWALK AT DRIVEWAY ENTRANCES TO BE 6" THICK
- WIDTH OF SIDEWALK ON ALL STREETS SHALL BE A MINIMUM OF 5'.
- CONCRETE COMPRESSIVE STRENGTH SHALL BE 3600 PSI. IN 28 DAYS
- ZONING CONDITIONS MAY REQUIRE ADDITIONAL WIDTH SIDEWALKS WHICH SHALL SUPERSEDE THESE STANDARD DIMENSIONS SHOWN
